### 1. Complying fund status of the Health Super Fund

### 2. Acceptance of employer contributions

The Health Super Fund is a standard employer sponsored fund and can accept contributions on behalf of new or existing members from any Employer Sponsor. Employers can apply to be a registered employer sponsor by phoning 1800 133 050.

If an employer is NOT an employer sponsor, Health Super can accept contributions from that employer provided that the employee is an existing member of Health Super.

| <b>Payroll file</b>      | Use a payroll bureau or an in-house payroll to transfer member details and payments automatically to us.  |
| <b>SuperData</b>         | A simple Windows-based application (SuperData) which can transfer super data at regular intervals direct from a payroll system. Suits small to medium-sized organisation.   |
| <b>Excel Spreadsheet</b> | Submit contribution data to us via email, using a pre-formatted Excel spreadsheet. We then transfer the data directly to the members' accounts. Download a copy of the spreadsheet from the Employer section of our website or ring us on 1800 133 050. |
